

The Controversial President of Somalia and US and Turkey Complicity

President Hassan Sheikh is the only who so far became twice President for Somali Federal Government. In both terms President Hassan showed very poor management capacity using state power shamelessly with tribalist tendency and personal interests as his priority instead of National interest at large.

President Hassan manages the office the Prime Minister and is involved in all offices of Legislative, Executive and Judiciary powers of the State. He normally appoints his children and close relatives in important and senior political and military positions. Jihan Hasaan Sheikh and Abdifatah Hassan Sheikh are well known examples by Somalis and International community.

Hiding or forceful and bribe based ratification of bilateral agreements and contracts without the normal procedural ratification of state cabinet and then Parliament is the normal and routine administration like the Turkey Somali Hydrocarbons/Oil agreement.

Tribalism and tribal interest of President Hassan Sheikh

President Hassan Sheikh normally tries to interfere, the Somali Federal member states (FMS) internal affairs for tribal ambition. On November 2014, Using Ugandan peace keeping troops President Hassan put on power an unelected Sharif Hassan by force and murdered innocent people and toppled the South west Federal State of six regions administration encompassing all Somali clans living in the six regions. He compromised with Sharif Hassan to nominate a Hawiye fellow as vice President of South West 3 regions, so many Mps and Ministerial position earmarked for his closerelatives. Sharif Hassan gave all the request of President Hassan Sheikh except the nomination of Vice President.

All the high rank of Somali National Army (SNA) officers operating in Lower shabelle region are from Abgaal and Habargidir clans and he uses them to consolidate the occupation of Lower shabelle region which started from 1991 where the indigenous people are displaced and their land taken over. For instance, these officers give false information to Turkish and American officers for drone bombardment of a given interested area with the pretext of fighting Al shabab. US

AFRICOM and Turkish are accomplices in this regard whether they are aware of or not and one day they will be accountable for their crimes. Bariire and Jambaluul village events are unforgettable deliberate crimes.

On December 2024, President Hassan attacked Raskiamboni to overthrow Ahmad madowe from Jubbaland presidency using (SNA) reason being he wanted some MPs and ministerial posts in Jubbaland but Ahmad Madoowe gave only for those live in Jubbaland but not others from far regions.

The anti-federal motive of President Hassan Sheikh

By corrupting the Speaker of the Parliament Mr. Aden madoowe and Mps, Hassan Sheikh unilaterally and unconstitutionally changed the Federal Constitution especially selecting articles which can be used for paving the way coupled with the unilateral nomination of the handpicked electoral commission are clear indicators for his ultimate self throne.

In addition, the use of the SNA to forcibly push for self interest and dictatorship diverting the SNA power from defending the nation against all forms of the country's enemy (internal and external) instead attacking and toppling Federal member states is another indicator of dictatorship. President Hassan attacked with all strength of the SNA and destroyed the South west Somali Federal state using Turkey arsenals (BMC Kirpi) and drones bayraktar gavin to Somalia for defense and not for internal conflict. Abdiaziz Hassan Mohamed Laftagareen was forced out of power as President of Somalia's Southwest State on 30 March of this year.

The unconstitutional nomination of South West regional Governors and deploying close relatives SNA officers in Barawa – the Capital of South West for community subjugation and land misappropriation and illicit and unconstitutional nomination of a transitional Governor for the whole South west FMS. Deployment of thousands of heavily armed SNA to Baidoa with the aim of totally disarming the natives of South West FMS and then enslave them. All these activities are executed to replace the Federal system of governance with a strong centralized unitary state system evolving to anarchy.

President Hassan Sheikh established his own party Justice and Solidarity Party (JSP) and forced the Presidents of South West, Hirshabelle and Galmudug FMS to become members of his parties and he kept them for three years without indirect

elections in their capitals through a compromise under gentleman's agreement to support each other within his party. But the three FMS Presidents discovered that Hassan Sheikh plan is him to become again President and the Lafta Gareen, Guudlaawe and Qoor Qoor just become idle in the market; that is why Lafta gareen came against Hassan's policy of self and became the first litmus paper for others.

The motto of President Hassan Sheikh is "only I can breach the law or the constitution" either by bribing and corruption of all kinds and or by force; all others must obey and follow my instructions otherwise I will destroy all using the US and Turkey trained SNA equipped with Turkey arsenals.

And now, President Hassan and his Prime minister are continuously and openly threatening all Federal Member States with a tyrant attitude inciting the SNA to attack and destroy every FMS disagreeing with President Hassans's policy.
